COVID 19 Acknowledgement, Liability Waiver & Release of Claims

Attendee assumes all risks and accepts sole responsibility for any injury (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that attendee may experience or incur in connection with attending the Greater Providence Board of REALTORS® Annual Meeting and Installation of Officers and Directors. Attendee hereby releases, covenants not to sue, discharges, and holds harmless the Greater Providence Board of REALTORS®, its employees, agents, and representatives, of and from any such claims, including all liabilities, claims, actions, damages, costs, or expenses of any kind arising out of or relating thereto.
